WHEREAS:

1. The Service Provider is engaged in providing internet services under the brand name "RailWire".
2. The Client is Sri Um pragathi First Grade College and has expressed interest in availing the internet services offered by the Service Provider.

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

1. Scope of Services: The Service Provider agrees to provide 100 Mbps unlimited internet services to the Client for the premises of Sri Um pragathi First Grade College, as per the terms and conditions set forth in this Agreement.

2. Duration: This Agreement shall commence on 01-07-2023 and continue until terminated by either party with notice in writing.

3. Charges and Payment:

- The Client agrees to pay the Service Provider a monthly charge of INR 999.00 plus applicable GST (CGST and SGST each at 9%) totaling INR 1,178.82.
- The payment shall be made by the Client to the Service Provider on or before the 30th of each month.

4. Payment Method: Payments shall be made through Partner Recharge or Pay to Payment Collection Agency (VANP) or as mutually agreed upon by both parties.

5. Taxes and Duties:

- All payments under this Agreement are exclusive of taxes. The Client shall be responsible for the payment of all applicable taxes, including GST as per prevailing rates.

6. Termination:

- Either party may terminate this Agreement by providing One Month Notice Period written notice to the other party.
- In the event of termination, the Client shall be liable to pay for the services rendered up to the date of termination.

7. Support and Maintenance:

- The Service Provider shall provide technical support and maintenance services as required for the uninterrupted use of the internet service.

8. Limitation of Liability:

- The Service Provider shall not be liable for any indirect, incidental, or consequential damages arising out of or in connection with the services provided under this Agreement.

9. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of India, and the courts in Tumkur Jurisdiction shall have exclusive jurisdiction.
